Program Description:



The purpose of this mini training event is to provide you with the most recent information on noteworthy foci in the field of HIV/AIDS.

Because Acute HIV is often

missed by health care providers, detection and early diagnosis for optimal patient health outcomes requires special consideration. We will discuss the role Primary Care providers play in the care of HIV positive persons, review the importance of HIV case finding to reduce the number of new HIV infections and discuss PrEP as a safe and effective HIV prevention strategy.

Target Audience:

Physicians, physician assistants, dentists, pharmacists, nurses, advanced practice nurses, social work and ancillary team members.

Program Objectives:

At the end of this program, participants should be able to:

1. Explain the clinical presentation, testing procedure and diagnosis, antiretroviral treatment and monitoring and secondary prevention issues specific to Acute HIV.
2. Discuss the appropriate medical and therapeutic evaluation of HIV positive persons through all stages of the disease process and identify ongoing and acute health maintenance considerations.
3. Discuss how HIV testing and implementation of HIV testing in Primary Care Centers/Community Health Centers has had an impact on reduction in disease transmission and new HIV infections in the US.
4. Outline the clinical practice guidelines on the use of PrEP in high-risk populations to make informed and appropriate recommendations about PrEP safety, efficacy, acquisition, and need for routine follow-up HIV testing.
