- Much of the District is closer to at least seven other state capitals than to Richmond, the capital of VA.





Geographic Challenges

The Health District faces several geographic challenges. The city of Wise sits at 2,451 ft. (747 m) elevation and the county has more snowfall than any county in the state at an average of 52.7" annually.

Our Population Data

- LHD serves the three counties of Lee, Wise and Scott, and the independent city of Norton spread over 1,381.72 square miles of land.
- The District office is located in the Town of Wise, in Wise County. LHD serves a population of approximately 88,145 (2017 population estimate, U.S. Census Bureau).
- According to census reports, the District is not considered "rural" but most who live or visit here consider it so. There is an average of 41 residents per square mile, or 640 acres, in Scott County; 516 in Norton; 55 in Lee; and 97 in Wise (2016 VDH demographic data).



Social Determinants of Health

There are social determinants of health and health behaviors that the District must take into consideration when conducting all-hazards planning, in addition to our diverse geography.

LENOWISCO has an average:

- 12% without health insurance
- 22.9% living in poverty
 - Lee County ranked 133rd out of 133 in the state for poverty rate
 - Wise County 124th out of 133
 - Norton 120th out of 133
 - Scott County 113th of 133

Social Determinants of Health

- 7% unemployment rate
- 30% children in poverty and 24% total population in poverty
- 15.3% Working Age Population with a Bachelor Degree and 18.25% Working Age Population without a High School Diploma
- 42.1% adults who report poor mental health (2015 VDH population data)
 - 30.7% adults 18 years and older who have ever been told by a health professional that they have a depressive disorder, including depression, major depression, dysthymia, or minor depression



Lenowisco Health District Employees

- Clinical staff (nurses, nurse practitioners, dental hygienist, physician)
- Epidemiologist

- Registered Dietitians/Nutritionists
- Social Work & Psychologist

Most Employees Work in Multiple Offices—Changing Locations Based on Staffing Needs

Protecting Health And Safety of Employees

- Additional case investigators/contact tracers hired to supplement staff as contract employees
- Retrain existing staff for utilization in new job roles; e.g. dental hygienist as case investigator
- Implemented flexible work schedules to ensure daily availability of case investigators/contact tracers for weekend/evening staffing
- Implemented flexible teleworking capabilities, supplying all case investigators and contact tracers with home laptops/cell phones

- Community partnership with Food City, grocery store chain with multiple locations in our area to establish drive-thru testing locations in every county served.
- Drive thru clinics are held multiple times weekly on a continuing basis. Staffed by LHD nurses and health educators.
- Have been very well attended; began at a time when were seeing great increase in local cases and there was elevated community concern

Free COVID-19 testing is available to all Virginia residents. An appointment and preregistration is *strongly* encouraged to make sure a test is available for you. For an appointment and pre-registration, please call the number listed for each testing site. A limited number of tests are available each day.

All passengers must stay inside vehicles from arrival to departure. Please bring a government issued ID (if possible). Testing staff will direct traffic flow, verify contact information, and perform a respiratory swab. Antibody testing is *not* available.

Testing times for results may vary depending on current laboratory load. Testing dates are subject to change due to inclement weather.

"Testing is important to monitor cases as we begin to re-open, so we can investigate, trace the contacts of those infected and mitigate the spread of illness. Remember that the best protection for each of us comes from personal precautions, including hygiene and physical distancing. That's how you protect yourself and those around you," said Eleanor Cantrell, M.D., director of Cumberland Plateau Health District and LENOWISCO Health District.

To lower the risk of spreading respiratory infections, including COVID-19, the Virginia Department of Health encourages everyone to:

- Stay home as much as possible, especially if you are at higher risk of serious illness. If you must go out in public, wear a cloth face covering;
- Stay home when you are sick;
- Avoid contact with sick people;
- Cover your mouth and nose with a tissue or your sleeve (not your hands) when coughing or sneezing;
- Wash your hands often with soap and water for at least 20 seconds; use an alcohol-based hand sanitizer if soap and water are not available;
- Avoid touching your eyes, nose, and mouth;
- Clean and disinfect frequently touched objects and surfaces;





Point Prevalence Surveys

 LHD has conducted multiple point prevalence surveys among congregate settings in our district including prisons, long-term care and assisted living facilities.



Reducing Spread of COVID-19

- Thorough education of cases and contacts regarding disease transmission and importance of isolation and quarantine.
- Education and counseling provided to persons requesting testing over phone and at curbside testing sites regarding disease transmission and crucial preventative measures.



Reducing Spread of COVID-19

- Getting the message out regarding the importance of mask wearing, handwashing, social distancing through social media, newspaper/press releases to local/community papers and media including television and radio
- Prompt contact tracing and implementation of isolation/quarantine of every case/contacts as soon as identified
- Daily conference calls among Health Director, District Epidemiologist, Nurse Manager, and epidemiology nursing staff to discuss cases, problem shoot any difficulties—communication and teamwork is vital
- Frequent contact between Health Director and Epidemiologist among community organizations such as local school boards providing guidance and answering questions regarding proper procedures

HIV/PrEP Patient Care During Pandemic

- Increased utilization of telehealth appointments; including initial PrEP visits
- Increased utilization of Positive Links for telehealth and connectivity (app for University of Virginia patients)
- Increased quantity of medication via refills (60 day supply vs. 30 day supply)



HIV/PrEP Patient Care During Pandemic

- Increased flexibility on home delivery of medications via mail
- Increased flexibility of refills of medication if unable to come in for labs (additional 30 day supply)
- Nurse-delivered medications to patients unable to come in for pick-up
- Nurse-delivered food and supplies to patients unable to obtain on their own

COVID-19 in Virginia: Demographics











Challenges/Lessons Learned

- Limited or no transportation with very sparse public transportation available
- Lack of providers offering testing (primarily an issue in the early months)
- Lack of COVID-19 knowledge among providers and the general public; specifically who should be tested and when
- Very limited rapid testing available; area residents often would need to travel excessive distances to obtain rapid testing



Challenges/Lessons Learned

- Declination of testing for religious reasons
- Reluctance to be tested due to concerns about being placed in isolation or quarantine and missing work



Answering Our Challenges

- Bring the testing to rural areas and those with limited healthcare options/providers
- Testing anyone who wants a test rather than limiting to those with symptoms or exposure
- Working with partners to expand testing (free clinics, FQHCs, hospitals, etc.)
- Promotion of public use of COVID WISE; Virginia's free phone app as aid to identify contacts to cases

Answering Our Challenges

- Community education and heavily promoting testing availability
- Reaching out to churches to offer testing onsite or offsite
- Encouraging our partners in congregate settings to do testing
- Rapid testing with immediate isolation and quarantine of cases and contacts.
- Media messages that focus on helping our community get back to normal (as opposed to mandates)
