Partnership

Health Resources and Services Administration (HRSA) Bureau of Primary Health Care (BPHC) supports this initiative to partner with Ending the HIV Epidemic-funded FQHCs in the MAAETC region

The University of Pittsburgh, School of Public Health, Department of Infectious Diseases is administering the project in partnership with MidAtlantic AIDS Education and Training Center (MAAETC) regional partners in the federally-funded Ending the HIV Epidemic jurisdictions (Philadelphia, Baltimore and Washington, DC) along with the National Clinician Consultation Center (NCCC) at University of California San Francisco (UCSF) which operates the “Warmline”, providing HIV treatment consultation with clinicians throughout the United States.

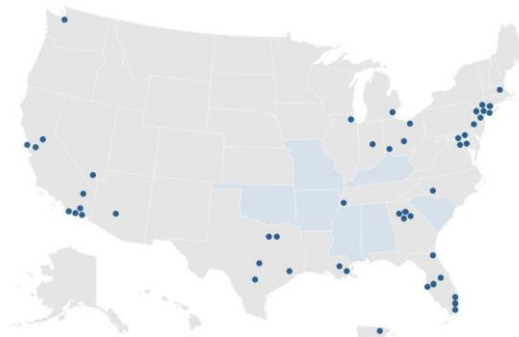
Ending the HIV Epidemic in the U.S.

GOAL:

75%
reduction in new
HIV infections
by 2025
and at least
90%
reduction
by 2030.

FOCUSED EFFORT

- 48 counties, DC, and San Juan account for 50% of new HIV diagnoses in 2016.
- 7 states with the most substantial HIV diagnoses in rural areas.



Led by HHS



Ending the Epidemic



Diagnose all people with HIV as early as possible.

Treat people with HIV rapidly and effectively to reach sustained viral suppression.



Prevent new HIV transmissions by using proven interventions, including pre-exposure prophylaxis (PrEP) and syringe services programs (SSPs).

Respond quickly to potential HIV outbreaks to get needed prevention and treatment services to people who need them.
